

SNOWFLAKE/TAYLOR YOUTH BASKETBALL 2012 REGISTRATION AND TRYOUTS

The Snowflake/Taylor Recreation and Parks Department will be conducting registration and tryouts for the 2012 basketball season at the Snowflake Jr. High School Gym. The registration waiver form below and fee will be collected at the tryouts. The tryouts will be used to rank youth according to their ability for assignment on teams. All youth, including the coach's son/daughter, need to tryout for an accurate count to determine the number of teams needed. Youth who sign up but who do not try out will be assigned (in order) to teams instead of being drafted by coaches - (No Exceptions). The number of youth that will be able to play depends on the number of coaches that volunteer. We hope to recruit enough coaches so that everyone will have a chance to play. These leagues play games on Saturdays. The seventh through ninth grade league will start after the Snowflake Jr. High teams are formed. Their games will be during the week between 6:00 and 9:00 PM.
